- All Source Protection Plan policies have been implemented.
- All relevant municipalities where significant drinking water threats may occur are Progressing Well/On Target
- Septic Inspections are Progressing Well/On Target (95 inspections in 2023 and only one system required minor maintenance.)
- Provincial Progress: Addressing Risks on the Ground is Progressing Well/On Target
  - 2 pesticide permits (both applied for and approved)

- 2 nutrient management strategy applications underwent review and were issued.
- Source Protection Plan Policy delays (SMF1 implemented through education and outreach. Updates forthcoming in Section 36 review.)
